AUTHORIZED BY THE OLDER AMERICANS ACT, THE PROGRAM OFFERS PAID TRAINING THROUGH PART-TIME COMMUNITY SERVICE ASSIGNMENTS FOR UNEMPLOYED, LOW-INCOME ELDERS. 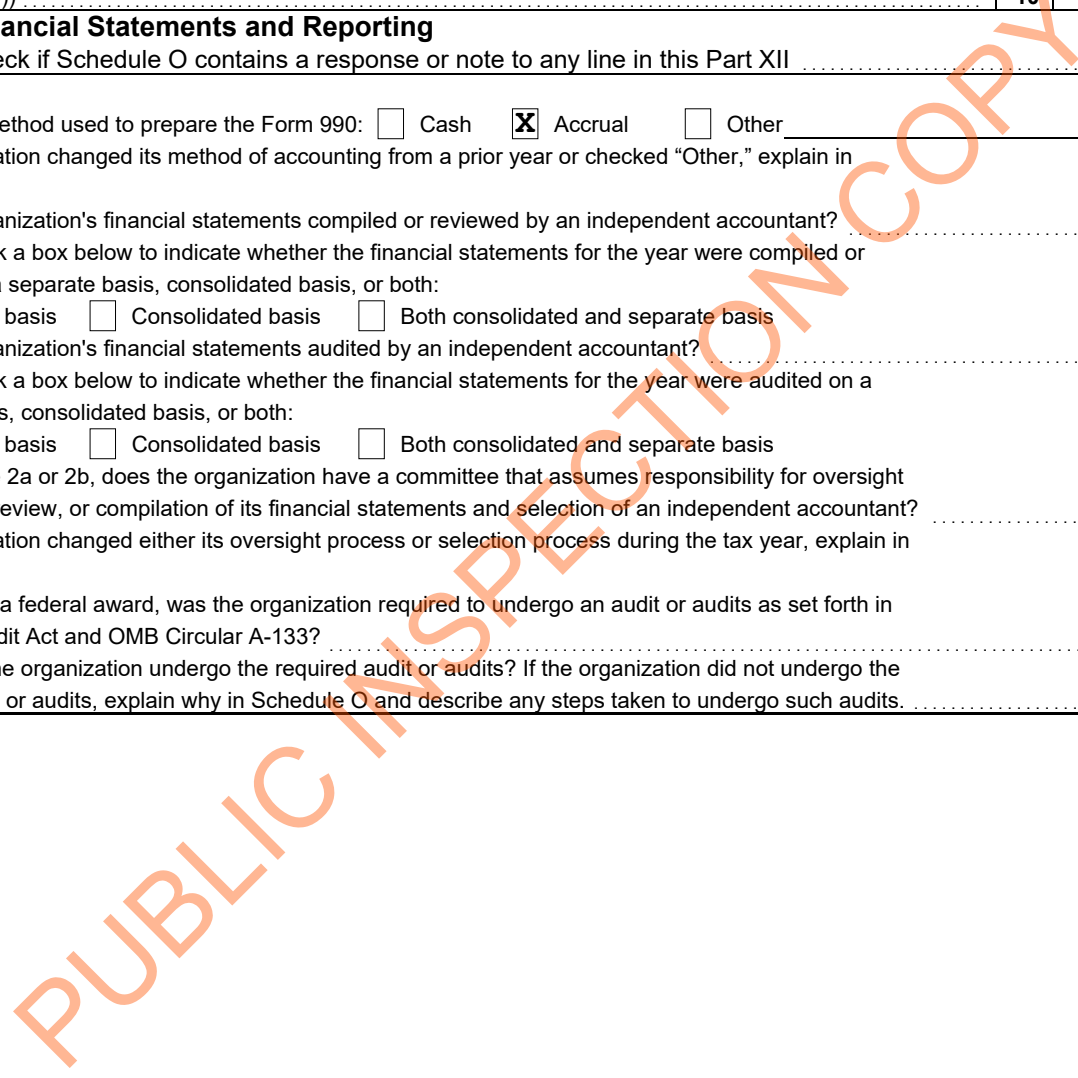
